

# TERMS AND CONDITIONS 2ND TURN BLANES TOURNAMENT 2026

## **A. TEAMS:**

### **1. DATES**

The Blanes Tournament will celebrate the 2<sup>nd</sup> Turn of its 16th edition from 02/04/26 to 05/04/26.

- Teams accommodated through the organization must arrive by Thursday, 02/04/26.
- The competition will begin on Friday, 03/04/26, at 09:00 AM, and the last matches will end around 6:45 PM on Sunday, 05/04/26.
- The closing ceremony and awards presentation is scheduled from 7:00 PM to 8:00 PM on Sunday, 05/04/26, at the Ciutat Esportiva de Blanes, after the last competition matches. Attendance is mandatory for all teams, except for special exceptions and prior authorization from the organization.

This is an indicative schedule. It may change depending on the organization's needs for the smooth development of the tournament.

### **2. CATEGORIES**

- **U11-U12 (MINI)** - Players born in 2014 and/or 2015
- **U13-U14 (INFANTIL)** - Players born in 2012 and/or 2013
- **U15-U16 (CADETE)** - Players born in 2010 and/or 2011
- **U17-U18 (JUNIOR)** - Players born in 2008 and/or 2009

There will be both female and male competitions in all categories. In the U12 (Mini) and U14 (Infantil) age categories, mixed teams may be accepted with prior authorization from the organization. These teams will be placed in the lowest level within the male category, except for special cases and with prior authorization from the organization.

### **3. LEVELS**

Once all team registrations are closed, the organization will assess and decide whether to have one, two, or multiple levels within each category based on the teams' levels. After deciding the levels, the organization will contact team managers to determine the most appropriate level for each team to compete in. If no agreement is reached, the organization's decision will prevail.

The levels will be determined based on the age and sporting level of each team in each of the eight categories mentioned in point 2.

If only one level exists within a category, groups (if any) will be formed by seeded teams. As the competition progresses, the teams in each group will be matched more equally.

#### **4. RULES**

The rules applied to all matches will follow the regulations of the FEB (Spanish Basketball Federation) and the FCBQ (Catalan Basketball Federation), with the following exceptions:

- The first three periods will be 12 minutes each with running time. The clock will not stop for free throws. The clock will only stop in cases of force majeure and when the referee indicates it. In the fourth period, the first 10 minutes will be running time, and the last 2 minutes will use FIBA's stop clock.
- The rest periods between the first and second periods and the third and fourth periods will be 1 minute each. The rest period between the second and third periods will be 3 minutes.
- Each team will have one timeout during the first two periods and one timeout during the third period and the first 10 minutes of the fourth period. During the last 2 minutes of the fourth period with the clock stopped, each team will have one timeout. Timeouts from the third and fourth periods are not cumulative.
- In case of a tie at the end of the match, overtime will be played with FIBA rules and stop clock. The first team to score three points will win the match. No timeouts may be requested during overtime.

#### **5. COMPETITION SYSTEM AND SCHEDULE**

Once the registration period is closed, the organization will create the competition system and schedule for each category based on two variables: the number of participating teams in each category and their competitive level.

When there are teams of different levels within the same age group or category and there are enough teams to create more than one competitive level, multiple levels will be created within the same category. If there are not enough teams, only one level will exist, and the groups will be formed by seeded teams. As the competition progresses, the level of the teams will equalize.

The competition system used for each category will depend on the number of teams in that category. Also, depending on the competition system, there may be multiple qualifying phases or a single round-robin league where all teams in the category face each other.

The schedules and competition systems will be published and sent to all teams no later than two weeks before the start of the tournament.

## **6. MATCHES**

All teams will play 4 matches throughout the tournament, regardless of results. The competition systems are adapted to ensure that every team plays this number of matches.

## **7. PLAYING COURTS**

All the courts used for matches are indoor courts, owned by the various municipal towns where the courts are located, and rented by the organization for the duration of the tournament.

The sports facilities are:

The organization reserves the right to relocate matches to other sports facilities in neighboring towns if necessary.

## **8. COMPETITION COMMITTEE**

In case of an exceptional situation, the competition committee, consisting of 3 members from the organization, will make the appropriate decision, and it will be irrevocable.

## **9. AGE CONTROL**

All players must be born in the years of the category they participate in. Exceptions may be allowed with prior consent from the organization.

It is mandatory for all athletes to carry an official identification document (ID card, passport, health card, NIE, etc.) during the tournament days. The organization may request the document at any time.

Any player who participates in a match without meeting these requirements will be excluded from the competition, and their team will lose all matches they participated in by a score of 0-50.

## **10. DISCIPLINARY MATTERS**

Any incidents or expulsions that occur during the competition (on or off the court) will be reported to the Competition Committee. The Competition Committee is the only body responsible for applying disciplinary sanctions. Sanctions imposed by the competition committee and their written resolutions cannot be appealed or changed.

## **11. SUSPENDED MATCH**

If a match is suspended for any incident or issue, the Competition Committee will decide the following parameters, considering the reason for the suspension:

- The match will be replayed from the beginning.
- The match will resume from the point at which it was suspended.
- The result at the time of suspension will be fixed as the final result.
- If the match cannot be played due to time or space constraints, the organization will offer an alternative to ensure a winner and a loser, so the competition can proceed.

## **12. GAMES SCHEDULE**

The organizing committee reserves the right to make changes to the game schedule, including match times and venues. Any changes will be communicated to the team manager.

## **13. PUNCTUALITY**

Teams must be present at the venue where their matches are to be played at least 30 minutes before the start of the match unless due to force majeure.

Similarly, when using transportation provided by the organization, teams must be present at least 5 minutes before the scheduled departure time at the designated departure point.

In cases of unjustified delays, the tournament competition committee reserves the right to forfeit the match for the late-arriving team, recording a score of 0-50 against them.

## 14. NUMBER OF PARTICIPANTS AND TEAM REQUIREMENTS

Each team must have a minimum of 9 players eligible to actively participate in the sporting activity. Rosters of 8 players will be allowed if players from younger teams within the same club can join the older team to meet the requirements. This condition may be flexible if it's authorized by the organization.

The coach of each team must be an adult. If the coach is not an adult, the team must have an adult representative who will act as the team's responsible figure.

If a coach is responsible for multiple teams, each team must have an adult representative as a member of its technical staff. In cases where match schedules overlap for teams managed by the same coach, and the coach cannot be present for all matches, the designated adult representative will act as the coach for the affected team(s). The organization cannot guarantee that match schedules for such teams will not overlap logistically or temporally.

## 15. TEAMS REGISTRATION

- The club representative (manager) must request club registration and the teams that want to register by emailing [info@basketmon.com](mailto:info@basketmon.com).
- After the confirmation of availability by the organization, it will pre-book the requested spots for the teams (or part of them) by the club manager (manager) during the period agreed upon with the organization.
- During this period, the club represented by the manager must pay €400 per team as a pre-registration fee to the bank account provided by BASKETMON and send proof of payment to [info@basketmon.com](mailto:info@basketmon.com). This initial payment of €400 will be deducted from the total registration fee for each team. If the payment is not made within the agreed period, the organization may release the pre-reserved spots without prior notice.
- Once the bank transfer is received, BASKETMON will send an email to the address provided by the club manager (administrator), which will include a link to access the platform for registering the coaches and participating players of each team in their club.
- Before accessing the platform, the club manager must fill in the following personal information: full name, ID number (or passport/NIE), full address, email address, phone number, and role in the club. Additionally, they must provide consent for data processing and agree to the terms and conditions of this document.

If the invoice is to be issued to the club, the following details must also be provided: full club name, full address, contact phone number, email, and tax ID number.

- On the platform, the club manager must fill in the following details for each participant: full name, date of birth, email address (for minors, the email of the parent/guardian is required), gender, ID number (DNI, passport, NIE, or health card), t-shirt size (if applicable), and preferred communication language (Catalan, Spanish, English, or French). Lastly, there is a comment box where additional information regarding the participant (illnesses, allergies, etc.) can be optionally added.
- Once all the required information has been entered, the club manager must send, through the platform itself, the link (which will be sent to the provided email address) so that the participant can give consent for data processing and image rights, as well as agree to the terms and conditions of this document.
- For minors, the email and consent must come from a parent/guardian, who must also provide their full name, ID number, and their relationship to the minor.
- Once the entire process is completed, the participant will be fully registered and enrolled in the tournament, pending the final payment of the registration fee for the team to which they belong.

## 16. DATA PROTECTION

## 17. PARTICIPANT FEES

### REGISTRATIONS:

- PLAYERS: €259.00
- COACHES: €175.00
- INJURED PLAYERS: €175.00

The fees include participation in the tournament with full board accommodation and internal transportation between hotel - sports facilities - hotel. Arrival: Thursday, 17/04/25 with dinner. Departure: Sunday, 05/04/26 with lunch.

#### ADDITIONAL SERVICES:

- EXTRA NIGHT: €52.00 (full board, shared room).
- SINGLE ROOM SUPPLEMENT: €25.00/night.
- OTHERS: The registration fee will increase by up to 10% for participants registered and authorized from 10/03/25 onward.

#### TOURIST TAX FEE:

The tourist tax is a tax imposed by the Generalitat of Catalonia and its cost is NOT included in the registration fee. All participants under 17 years of age on the day of check-in at the hotel are exempt from paying this tax. However, participants who are 17 years old on the day of check-in at the hotel will be required to pay the tourist tax directly at the hotel reception upon arrival, with a cost of €0.66 per night.

### 18. PROMOTIONS AND DISCOUNTS

- One coach will receive free registration for teams with 10 or more players.
- A €10.00 discount on player registration fees (not applicable to injured players or coaches) is available for clubs registering 5 or more teams.
- Teams that pay the €400 pre-registration fee before 31/01/2025 will receive an exclusive tournament basketball t-shirt. Teams paying after this date will receive the standard t-shirt, with the option to upgrade to the exclusive t-shirt by paying an additional €12.00.
- Participants registered and authorized from 10/03/25 onward will not be entitled to either of the two t-shirt options. If they wish to purchase one, they must pay an additional fee of €12.00 for the basic t-shirt and/or €15.00 for the exclusive t-shirt.
- The t-shirts will be distributed on-site during the tournament. T-shirts requested after 09/03/2025, in case the organization has not received them from the supplier before the tournament, will be sent to the address provided by the club manager with the **shipping costs payable by the recipient.**

### 19. PAYMENT DATES

- **First Payment:**

To pre-register a team, a payment of **€400** is required as a deposit. There is no specific deadline, but to benefit from the exclusive t-shirt promotion, the payment must be received by **31/01/2025**. This payment will be deducted from the final amount to be paid by the team. Once this payment is made, the team will be pre-registered for the tournament, and the spot will be reserved until the second payment is made.

- **Second Payment:**

All teams that have made the €400 deposit payment must make a second payment of **€60 per player** by **23/02/2025**. Teams that have not made the €400 payment earlier must also do so by this date.

Additionally, by this date, the team must inform the total number of participants in the tournament, which must comply with the parameters outlined in point 14 of this document. **Any new additions after 23/02/2025 must be authorized by the organization.**

- **Third Payment:**

The remaining balance must be paid no later than **09/03/2025**. Additionally, by this date, **the total number of participants attending with the team must be confirmed and properly registered on the tournament platform.**

**Once this payment is made, the team will be fully registered for the tournament.**

Failure to comply with the deadlines, amounts, and dates set will result in an increase of up to 10% in the final registration cost for all team members. Additionally, the organization reserves the right of admission and may cancel the participation of any and/or team if they do not comply with the established rules.

## **20. ACCOMMODATION**

Accommodation is provided on a full-board basis. The first service will be dinner on the day of arrival, and the last service will be lunch on the day of departure. For teams staying extra nights, the first and last meals will be agreed upon between the team or club and the organization, subject to approval.

The organization assigns the hotel and will communicate it to the team 15 days before the tournament. Room distribution for players and coaching staff will be assigned by the organization. Teams cannot have any players or coaches of their team without accommodation.

### **Check-in:**

Teams whose first service is dinner can access the rooms from 17:00. Teams whose first service is lunch can access the rooms from 13:00. If rooms are available earlier, access will be allowed. To speed up group check-in:

- It is important to bring a list with players' names, marked with the contact information of the responsible person.
- Have the IDs (or identification documents) of all participants ready. It is recommended to bring a copy of the documents as it will speed up the process.
- Participants who are 17 years old at the time of check-in must pay the tourist tax at the hotel through the responsible person, at a cost of €0.66 per night.



### Check-out:

On the departure day, rooms must be vacated by 10:00. Hotels have a luggage storage service until check-out time. At the Ciutat Esportiva de Blanes, there will be a set of lockers used as a luggage/storage area, locked for security.

### Preventive Deposit:

Each group leader (coach/coordinator) must leave a deposit of €20 per player, which will be refunded once the hotel verifies that no damages have been caused by the group. This deposit, which is managed by the hotel, can be paid in the following ways:

1. In cash at check-in (handed over by the group leader), and it will be refunded on the day of check-out to the same responsible person.
2. Bank transfer prior to check-in. It will be refunded one or two days after check-out.
3. Providing a credit card number along with an authorization signed by the cardholder. Upon the group's departure, if there are no damages, the hotel will return the authorization to the group leader, sealed as correct.

The chosen method of payment for the deposit must be communicated to the organization two weeks before the group's arrival.

## **21. TRANSPORT**

Internal transport to and from the games for each team from the hotel to the sports venue is included in the registration fee for participants. Any other transport not exclusively related to the team's games is NOT included.

If any participant wishes to use a transport other than the one assigned for their matches, they must inform the person responsible for transport within the organization via WhatsApp (we will provide the phone number). If there are any available seats on the requested transports, these seats will be offered on a first-come, first-served basis, and the authorization of the person responsible for transport will always be required. If there are no available seats, the organization will notify the participant via WhatsApp.

Teams that require extra transport to matches (such as transport to airports, ports, train stations, etc.) must request a quote from the organization, and if accepted, make the payment for the service before it is provided.

## 22. INSURANCE

The organization holds liability insurance as an event organizer and as a travel agency. Additionally, it also has sports accident insurance, as required by the competent authority in the territory where the tournament takes place (Generalitat de Catalunya), which covers injuries and sports accidents that may occur during the sporting activities of the event. These insurance policies are available to club officials or any participant, who can request them at any time via the tournament's communications email.

Any other coverage beyond those mentioned (theft, illnesses, etc.) must be arranged by the club, team, or individual themselves. The organization will not be held responsible for any incidents outside the coverage provided by the aforementioned insurance policies.

## 23. CANCELLATION / REFUND POLICY

Any club or team has the right to cancel their registration for the tournament within 14 calendar days from the date of registration. This period starts from the day the organization sends the link to the club or team manager to access the tournament platform for registering participants. To cancel, the club or team must notify us in writing, and a "WITHDRAWAL FORM" is provided at the end of these terms, although its use is not mandatory. This notification will be valid as long as it is sent within the specified period, and there is no need to state the reason for the withdrawal. Any payments made will be fully refunded within 14 calendar days from the receipt of the withdrawal notice. Other cancellation cases will be reviewed by the organization, and a decision will be made based on the following points. Any situation not specified will be considered unique by the organization, which will inform the club or team manager of the outcome.

### 23.1 TEAM PARTICIPATION CANCELLATION

Teams must make a €400 pre-registration payment to guarantee their spot. This amount will be deducted from the final amount to be paid and, once the 14 calendar days of the withdrawal period mentioned in point 23 (previous paragraph) have elapsed, it is non-refundable, as it is for securing the spot. Changes to teams will only be allowed, **subject to organization approval**, until the second payment date (23/02/2025).

The remaining balance of the full registration must be paid by **09/03/2025**. By this date, the total number of participants attending with the team must be confirmed and registered on the platform.

Once the full payment has been made, NO refunds will be issued. If the payment is not made within the set period, the organization may cancel the team's participation, and they will forfeit any payments made up to that date.

Note on the promotion of €10 discount for 5 or more teams from the same club:

If the cancellation of a team causes the club to no longer meet the conditions for the promotion of -€10 off for clubs entering 5 or more teams, the remaining teams from the club will lose the promotion. For example: A club that registers 5 teams is eligible for the promotion. If one of the teams cancels, the other 4 teams will lose the discount.

**23.2 PARTICIPANT CANCELLATION (players and coaching staff)**

The registrations of participants are managed by the clubs/teams through their manager. Any cancellations and/or refunds for participants must be managed between the manager and the organization. Under no circumstances will refunds be given directly to participants or their families. All cancellation or refund requests must go through the manager and the organization.

- **Cancellations between 23/02/2025 and 09/03/2025:**

If a pre-registered participant withdraws during these dates, the organization will refund 80% of the total registration fee for that participant.

New registrations will be allowed to replace the participants who have withdrawn. In this case, the registration fee for the withdrawn player will be compensated by the newly registered player, and the withdrawn player will not be penalized with the 20% deduction from the registration fee.

- **Cancellations after 09/03/2025:**

The organization will not issue any refunds unless it involves a force majeure reason, duly documented with official documents.

New registrations will be allowed to replace participants who have withdrawn, with an additional cost of 10% of the registration fee.

Note on the tournament T-shirt:

Regarding the tournament t-shirt, neither the player who was canceled nor the newly registered player will receive a t-shirt unless they wish to buy one. The basic T-shirt costs €10, and the exclusive t-shirt costs €15. If the organization has it available before the tournament, it will be given to the club's responsible person or a designated third party to deliver to the participant. Alternatively, if the T-shirt is not available during the tournament, it will be sent to the provided address two weeks after the tournament's conclusion, with **shipping costs paid by the recipient.**

Note on the promotion of free coach for 10 or more players in a team:

If participant cancellations prevent a team from meeting the conditions for the free coach promotion, the team will lose the promotion. For example: A team of 10 players + 1 coach is eligible for a free coach. If a player cancels, reducing the number of players to 9, the promotion will be lost, and the team will need to pay for the coach's registration.

## **24. RULES OF ORDER**

Coaches are responsible for their players in case of damage to lockers, hotels, buses, or other facilities. Silence must be observed in hotels between 11:00pm and 08:00am. Meal schedules set by the hotel management must be respected. Traveling without a shirt in the organization's transport is prohibited. The entry of alcohol or other substances not allowed for minors into rooms is prohibited. Failure to comply with these rules by any player, coach, or companion may result in expulsion from the tournament.

## **25. CANCELLATION OF THE TOURNAMENT DUE TO FORCE MAJEURE**

If the tournament must be canceled due to force majeure beyond the control of the organizers or due to situations that cannot be attributed to negligence on the part of the organization, they cannot be held liable for damages, costs, or losses incurred, such as transportation costs, accommodation, economic losses, etc. In this case, the tournament organizers reserve the right to retain the full fee and use it for a future tournament or refund the affected parties after deducting the expenses incurred by the tournament organization with third parties that cannot be recovered.

## **26. NON-COMPLIANCE**

Failure to comply with any of the rules detailed in this document or those imposed by the organization with prior notice will be sufficient reason for the organization to cancel the participation of participants and/or teams.

## **27. MODIFICATION**

Any circumstance not reflected in the regulations will be the exclusive responsibility of the tournament organizers, and their decisions will be final. The organizers reserve the right to add, modify, interpret, and apply the rules according to their criteria and the needs of each tournament. The organization reserves the right to amend these rules for the benefit of the competition. Any changes made to these regulations will be communicated in writing to the club and/or team representative.

## **B. ACCOMPANYING PERSONS:**

The organization provides a number of rooms in one or more hotels for those accompanying tournament participants who wish to stay in Blanes during the tournament, as well as for a few days before or after the event.

The commercial relationship between Basketmon and accompanying persons making one or more hotel reservations through Basketmon will only pertain to the reserved hotel rooms. No transportation or any other service beyond the contracted hotel reservations is included.

### **• RESERVATION PROCESS**

Reservations will be made individually by the person making the booking and will be independent of any team participant registration.

To formalize a reservation for accompanying persons, the form (accessible via the tournament website) must be completed with all required information, including the desired hotel from those offered, the reservation dates, and the selected meal plan. Additionally, when required by the hotel, the first and last meal service (breakfast, lunch, or dinner) must also be indicated. Once the form is completed, it will be sent online to the organization.

Within two business days, the organization will confirm the availability of the requested reservation and send the total price. The customer must pay the reservation amount within two business days. If there is no availability at the requested hotels or on the requested dates, the organization will inform the customer. If alternatives are available, they will be offered for the customer to accept or reject.

### **• PAYMENT METHOD**

Payment can be made via bank transfer or credit card. The customer may choose the most convenient payment method, provided the organization is informed of the chosen method in advance.

### **• CANCELLATION/REFUND POLICY**

Once the reservation is confirmed, no 100% refunds will be issued unless there is a force majeure reason, duly justified.

If the customer wishes to cancel the reservation and notifies the organization at least fifteen days before the start of the activity or event, BASKETMON will refund 80% of the total reservation amount. If notified later than the indicated period, no refund will be issued.

If an accompanying person cannot attend the activity or event, BASKETMON will accept a replacement of the accompanying person, provided the organization is notified three days before the start of the activity or event. This policy is particularly important given that many participants are minors.

## **C. TEAMS AND ACCOMPANYING PERSONS:**

### **• REFUND POLICY**

In the event that a refund must be issued, BASKETMON will process the reimbursement of the amount paid using the same payment method used by the CLIENT within a period not exceeding 14 calendar days from the confirmation of its acceptance by BASKETMON.

### **• LANGUAGE**

For informational and contractual purposes, the communication language will be the one selected: Catalan, Spanish, English, or French. Translations into different languages are made solely for commercial purposes. In case of divergence or incompatibility between the versions in different languages and the Spanish version of these general conditions of sale and use, the Spanish version will prevail.

### **• CLAIMS**

### **• APPLICABLE LAW AND COMPETENT JURISDICTION**

These terms and conditions are governed by Spanish law. BASKETMON and the user agree to submit any disputes that may arise in connection with the contracting of products or services covered by these General Conditions to the courts of Blanes (Girona, Spain).
